 - i. QCLI:

Presented by Judah Cooper, President. queensbrainwaves.com About: Neurotech research team. Benefits: Working with elec, mech and comp skills, research opportunities, industry connections, and data science. Ratified by AMS this year, worked on development of EEG in early 2020. Bitbrain Q: Spencer Lee (EngSoc President); Insurance issues with human trials and research, how are they testing?

A: Judah Cooper; Been in contact with council pre-Covid, but online data sets for now. Will look into this post Covid.

Q: Spencer Lee; (EngSoc President); How do you know that there is interest and what do you expect it to be?

A: Judah Cooper; A lot of interest already, as tech improves, demand will rise.

ii. QVFT:

Presented by Patrick Singal, Managing Director. qvft.com

About: First of its kind, undergrad vertical farming, goal is to start a vertical farm at Queen's. 20 members now, interdisciplinary. Uses 95% less water than traditional farming.

Covid plan: 2D design into 3D CAD model but revised to finish 3D CAD model. Software team is working on sensors and hope to start building physical prototype next year.

ZIPGROW offered a \$200,000 vertical farm at Queen's, hopes to install in the next year. Long-term, iterate on prototype and produce lettuce and kale, and give back to community.

Q: Spencer Lee (EngSoc President); One thing that you touched upon was about selling the produce that you grew. Just a note that EngSoc is a non-profit and there cannot be any businesses under EngSoc so any money gained could not be used as profit and would have to be donated.

A: Patrick Singal; Hoping to run student run business under ZIPGROW, efforts will be kept separate off EngSoc. Main goals are charity and education.

iii. Queen's Recon:

Presented by President Nicholas Wilkinson.

About: Seeks to connect engineers with companies and projects throughout the year. Covid Plan: Plan to acquire five new clients by the end of the year, connect members with clients by Winter 2021.

Q: Spencer Lee (EngSoc President); Was the overlap with professional development and this club intended and noted for workshops etc..., if so, was there any intention to make them separate?

A: Nicholas Wilkinson; Not considered and will be investigated.

iv. QCTF:

Presented by Nathaniel Pauzé, Ted Brownlow, and Raed Fayad.

About: Cyber security capture the flag event. Participants use knowledge of math, logic, and comp sci to complete challenges.

Goal is to help gain hands on experience in the industry. They have enough money from Amazon to cover the costs for the event.

Covid Plan: Not affected by Covid. Plan to be held Nov 21-22nd 2020.

Q: Spencer Lee (EngSoc President); What topics would the competition revolve around because I am interested to see how our engineering membership would be interested in this?

A: Nathaniel Pauzé; Reverse engineering, cryptography, general computer, security, and software.

Q: Alex Koch-Fitsialos (VPSA); Is this event friendly to newcomers? What prior skills are needed?

A: Ted Brownlow; Yes, with an equal distribution of difficulties, hint system.

Q: Brian Seo (Director of C & C); Once the conference is established, how would you expand beyond the university scope?

A: Part of future expansion plan, reaching to other universities. Nothing prohibiting other students from joining online.

v. MetSoc: Presented by Susanna Zhang (President), and Aishat Usman (Vice President).

Goals: Talks, lecture series, mentorship program, conferences in metallurgical and material science field.

Covid Plan: Virtual speakers and conferences, promoting safe practices through public health, entirely virtual settings, regular online meetings.

Some goals are to maintain starting balance and students by end of 2020. Improve funding and start in-person meetings and socials. Industry focused fieldtrips in 2023 within and outside of Kingston.

vi. NSBE: Presented by Genevieve Norris-Roozmon, President.

Goal is to provide support and mentorship with Black-identifying Queen's Engineering Students. Host programs to develop student interest in engineering, promote participation at all levels of responsibility in the field of engineering. Monthly club events, and regular club events.

Covid Plan: Virtual mentorship, socially distanced events, sharing resources online, community established meets.

Free of charge membership but there is a NSBE membership fee which can be paid to access more resources.
